Revisions to the Reference Statistical Prices for OTC Bond Transactions

1. Revisions

- (1) Day-to-Day Changes of Average Price, Highest Price, Lowest Price and Median Price Of the reference statistical prices published in August 28, 2017, the number of Designated Reporting Members was fewer than 5 for 437 issues, and thus the prices were not published. However, for the following business day (August 29, 2017), the day-to-day changes in average, highest, lowest, and median prices for the aforementioned 437 issues were published. Hence, the day-to-day changes in average, highest, lowest, and median prices for the 437 issues published August 29, 2017 have been removed.
- (2) Issue Type, Information (Deviation)

Within the published reference statistical prices, a mark (in the PDF/Excel data, this is an asterisk within the "deviation" column; for the CSV data, this is a "1" in the "Issue Type/Information 1" column) is put on issues whose difference (absolute value) between the highest and lowest quotations is more than 0.5%.

However, for the reference statistical prices published from November 10, 2015 to May 3, 2018, 22 issues that did not publicize their quotations were marked with an asterisk/1. This has since been deleted.

3. Handling of Corrections Comparison Table

Regarding the revisions to the reference statistical prices, the corrections made after publication of the prices of errors due to system errors, etc., are usually collated in a comparison table; however, as this particular instance does not feature actual errors in the values of the reference statistical prices themselves (i.e. the average, highest, lowest, and median prices), and as this revision covers a much larger time frame and many issues, the comparison table is difficult to create. Accordingly, this notice has been released in place of said comparison table.

Furthermore, the reference statistical prices released on the JSDA website (CSV, Excel, and PDF formats) from September 18, 2019 onwards reflects the above changes.
